*I confirm I am a taxpayer. I understand that:

- Shine Relief Trust will reclaim tax on all qualifying gifts made this year, in the future and previous four years.
- If I pay less income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all charitable donations I make in that year it is my responsibility to pay any difference.
- It is my responsibility to notify the charity if my personal details change or I no longer pay sufficient tax or cease to be a taxpayer.

I confirm I have paid or will pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities or Community Amateur Sports Clubs (CASCs) that I donate to will reclaim on my gifts for that tax year. I understand that other taxes such as VAT and Council Tax do not qualify. I understand the charity will reclaim 25p of tax on every £1. If you pay Income Tax at the higher rate, you must include all your Gift Aid donations on your Self-Assessment tax return if you want to receive the additional tax relief due to you.
